Procedure Learning Agreement

- Print the document, sign and scan it.
- Send the learning agreement together with your transcript of records to the responsible departmental coordinator for their assessment and signature.
- Once the learning agreement has been signed by both you and the departmental coordinator, upload it to Mobility Online. If you have more than one learning agreement (e.g. one for your major and one for your minor), you have to merge it into one single document before the upload.
