REQUIREMENTS FOR ABSTRACTS

- The text of the abstracts should be typed in the Microsoft Word text editor and saved in *doc or *docx format.
- The volume of materials is 2-3 full pages of text in A5 format;
- The number of sources used should not exceed 5 names;
- The text is printed in Times New Roman font, size 10 pt, interval 1, paragraph 1.25 mm, width alignment; margins: top and bottom 20 mm; left 15 mm, right 15 mm;
- Abstracts must be correct and not contain materials or ideas that may have signs of academic plagiarism;
- The author is responsible for the content and uniqueness of the submitted material;
- The Editorial Board reserves the right to partially edit the material that is executed or designed in violation of the above requirements.
