Form of participation: online.

The Organizing Committee reserves the right to reject abstracts if they do not comply with the requirements or do not correspond to the conference topics.

Languages of the conference: Ukrainian, English.

Participation in the conference is free of charge.

The electronic collection of abstracts will be posted on the conference webpage and sent to all authors.

### **REQUIREMENTS FOR ABSTRACTS**

- The abstract text must be prepared in Microsoft Word and saved in \*.doc or \*.docx format.
- Length: 2-3 full pages, A5 format.
- Number of references: up to 5.
- Font: Times New Roman, size – 10 pt; spacing – single; paragraph indent – 1.25 mm; alignment – justified.
- Margins: top and bottom – 20 mm; left – 15 mm; right – 15 mm.
- Text should be formatted without hyphenation, justified to the full width of the page, and pages should not be numbered.
- Tables, figures, and formulas should be avoided, except in cases of urgent necessity. Each illustration (diagram or chart) must be captioned (clear and grouped), each table must have a title, and formulas must be created with Microsoft Equation and numbered in parentheses.
- The reference list should include only the sources cited in the text. Example of reference formatting: [1, p. 45]. Multiple references should be separated by semicolons [1; 2]. References must be formatted according to the established requirements (in line with the National Standard of Ukraine DSTU 8302:2015 “*Information and documentation. Bibliographic reference. General requirements and rules for compilation*”).
- For students and postgraduate students, a supervisor’s review is mandatory unless they are listed as co-authors (a scanned review should be attached as a separate file, or the first page of the abstract scanned with the signatures of the author and supervisor next to their surnames).
- The author is responsible for the content and accuracy of the submitted materials (all materials are published in the author’s version).
- The Editorial Board reserves the right to partially edit materials that do not comply with the above requirements.
- Each author may submit no more than three abstracts.
