



## **AGREEMENT on COOPERATION**

The parties hereby agree to promote the academic exchange and develop activities of mutual interest in accordance with their respective needs and objectives and shall, by joint agreement, determine the areas and subject of such cooperation.

Cracow University of Technology and Zaporizhzhya National Technical University ( Ukraine) agree upon the following principles of cooperation:

### **§ 1**

1. Both institutions shall promote the exchange of information on their educational programs, research activities and areas of potential mutual research cooperation. Both institutions will promote the exchange of faculty staff and students.
2. Both parties agree to collaborate in the following relevant areas:
  - a) exchange of students and/or interns;
  - b) exchange of faculty and staff;

- c) joint research activities, publications;
  - d) joint conferences, seminars, workshop, and meetings;
  - e) double diplomas.
3. In the event that specific exchanges of faculty, staff and students or research projects are identified, this is to be determined through a separate Appendix or Annex to this Agreement, which is to be written and signed by both parties.

§ 2

1. This agreement shall remain in force for five (5) years from the date of the last signature, with the understanding that it may be terminated by either party giving 6-month prior notice to the other party in writing. Unless written notice of intent not to renew is provided by either party at least thirty (30) days prior to the scheduled expiration date of the then current term, this agreement shall be automatically renewed for successive five (5) year additional terms.
2. Both universities may at any time review this Agreement and the actions taken under it. Modifications to this agreement can be made only in writing by mutual consent.
3. This Agreement has been written in four copies, two in the English, two in the Polish, signed by both parties. All the texts are equally authentic, yet in case of any discrepancies the English language version shall prevail.
